Establishing a Director ID

A step-by-step guide for domestic directors

Step 1: Set up your myGovID.

- i. Using a smart device, download the myGovID app from the Apple App Store or Google Play store.
- ii. Enter the required details, including name, date of birth and email address. Use a personal (rather than work or shared) email address.
- iii. A list of options will become available for you to upgrade your identity verification strength from "Basic". In order to have a Director ID, your account must have at least "Standard" identity verification strength.

v. Once your myGovID is established, it will tell you the strength of your identity.

An eligible officer is: > an appointed director or alternate director (acting in that capacity), of a company, body corporate that is a registered Australian body or registered foreign company.	
The Registrar may make a determination that a particular person or class of persons are not eligible officers.	
You should not apply for a director identification number if you already have an active director identification number unless you have been directed to by the Registrar.

To be eligible to be a director of a company, you must:
